

StudentInformation v15.1.0 provides several new features and resolves some issues to improve your experience. This overview explains the recent changes.

Enhancements

Family Groups

- (E10123) A script is available from your technology center to remove the address information from the **Description** field on the **Family Groups** screen and in the family group information on the **View Profile** screen for any family groups created prior to the v15.0.0 release. (For v15.0.0 and later, the address information is not included in this field when you create new family groups.)

Security

- (E6509) A check now occurs when you are creating a new user in the system to prevent a StudentInformation user from being created if the CentralAdmin user creation fails. Because of this enhancement, you no longer need to manually clean up orphaned users in either CentralAdmin or StudentInformation if there is a failure to add the user to one or the other. (*ProgressBook StudentInformation Security Guide*)
- Address auto-complete functionality has been added to the **Security - Staff Member** screen. When you add or edit a staff member's address (and have not selected to **Bypass Address Standardization**), as you enter a street number and name in the **Address** field, suggested addresses display in a drop-down list. You can select the correct address and the system automatically validates it, as shown when the  icon in the **Zip Code** field changes to  (green). (*ProgressBook StudentInformation Security Guide*)
- (E10083) A new **GBServiceAuthenticateStudent** node has been added to the **Security - Role** screen under the **VendorLink REST** folder. The node controls access to authentication of student accounts in ParentAccess using the new VendorLink AuthenticateStudent API.
- (E7004) A new **SISServiceTransportation** node has been added to the **Security - Role** screen under the **VendorLink REST** folder. The node controls access to the StudentTransportation object in VendorLink.

Contact Type Codes Maintenance

- An additional **Is Publicly Viewable** option has been added to the **Contact Type Codes Maintenance** add/edit screen in the **Default Settings for Contacts of this type** section. Your selected value controls the default value of the **Publicly Viewable** option on any new contacts you create on the **Add Student Contact** window. Report Card Formatter (R700)

- A new **Run Ready Jobs** button has been added to the add/edit version of the **Report Card Formatter /R700** screen **Load Settings** tab. When you click this button, any pending report card jobs run immediately without you having to wait for the next scheduled JAMS job. (*ProgressBook StudentInformation Marks Guide*)

I Want To... Menu

- A new **View Student Roadmap** option has been added to the **I Want To...** menu on both the masthead (student in context area) and the **View Profile** screen. If you have DataMap installed and registered and you have access to a student in DataMap, you can view that student's **Student Roadmap** screen by selecting this option. Resolved Issues

EZ Query

- (D7129) OGT scores were incorrectly omitted from the **(EZ Students) Shared Student Data (JVS/Home)** screen if the **Building IRN - Spring Test Administration** field on the OGT record (which displays in the grid on the **OGT** screen as **Mar Admin IRN**) did not contain a valid IRN. In this release, the scores are included even when the **Mar Admin IRN** value is *****.
- (D8696) Previously, the **SIS Student Search** ran slowly at times. Changes to the database have been made to improve the speed.
- (D7111) Previously, the **SIS Student Search** excluded a student's mailing address information in the search results if the student had no contacts. Now, regardless of whether the student has a contact, the student mailing address is returned in results whenever you select it in the output (on the **Field Selection** tab **Addresses & Contacts** subtab).
- (D2820) The **SIS Student Search** did not return the **LEP Reclass Date** value from the **FD-Attributes** tab of the student profile when you selected the **Limited English Proficiency** and **LEP Class Date** options on the **Field Selection** tab **EMIS** subtab. In these circumstances, the results now correctly include the **LEP Reclass Date** value.

- (D3608) On the **SIS Student Search**, the **Primary Contact Relationship Comments** option on the **Field Selection** tab **Addresses & Contacts** subtab incorrectly displayed comments from the **Contact Comments** field on the contact record instead of the **Relationship Comments** field. In this release, the option correctly displays comments from the **Relationship Comments** field.
- (D5425) The **SIS Student Search** did not return any results when you had a summer school term in context. Now, the search works correctly and returns results for summer school terms.
- (D7112) The **(EZ Students) Course History** screen did not display summer school course history when you had the following school year in context. Now, in these circumstances, summer course history correctly displays.
- (D9750) On the **(EZ Students) Demographic** screen, the **Withdrew To** column incorrectly displayed the value of the **Withdraw to District Comments** field on the **Withdraw Student** screen instead of the **Withdraw to District IRN** field. In this release, the option correctly displays the IRN from the **Withdraw to District IRN** field.
- (D6769) Previously, if you ran the **List Of Students Without Disciplinary Incidents** report for **Active Students**, the list only included those students with a **Student Status** of **A - ACTIVE RES**. Now, in these circumstances, the list correctly includes students with a student status code showing an **Overall Student Status** of **Active**.

Graduation / Eligibility Rule Setup

- (D8870) Previously, you were unable to add an element of **GPA** to a graduation rule line item on the **Graduation / Eligibility Rule Setup** screen. In this release, you can successfully add the **GPA** element to a graduation rule line item.

Transcript Formatter (R702)

- (D7122) In a previous release, some needed selections were removed from the **Sorting Options** multiselect list on the **Transcript Formatter (R702)** screen. In this release, the following selections have been added back as sorting options:
 - **Grade (ASC)**
 - **Grade (DESC)**
 - **Student Name (DESC)**
 - **Homeroom (ASC)**
 - **Homeroom (DESC)**
 - **Program (ASC)**
 - **Program (DESC)**
 - **Homeschool (ASC)**
 - **Homeschool (DESC)**
 - **Student Status (ASC)**
 - **Student Status (DESC)**

Bulk Enroll Pending Students

- (D9000) When you bulk enrolled students at a JVS on the **Bulk Enroll Pending Students** screen using an **EMIS Situation** of **358 - Vocational Evaluation only** and a **How Received** value of **F - Student receiving career assessment services only** along with the **How Received IRN** of the sending district, when you processed the enrollment, the **How Received** value changed to ***** and the **How Received IRN** changed to ********* on the student profile **FS-Standing** tab with errors indicated. In this release, when you bulk enroll students using these values, the values are set correctly on the student profile **FS-Standing** tab.

Attendance Reports

- (D8421) Previously, when students had contacts marked as **Copied on Correspondence**, duplicate copies of the **Period Absence Letter (R317)** and **Half/full Day Absence Letter (R320)** did not print. In this release, one copy of these reports correctly prints for each contact marked **Copied on Correspondence**.

Fee Reports

- (D3611) The **Student Fee Invoice (R108-C)** report did not correctly filter results based on the parameters you selected on the **Selection Criteria** screen. The report now filters the results correctly based on your selections.
- (D9566) Previously, when students had contacts marked as **Copied on Correspondence**, duplicate copies of the **Student Fee Invoice (R108-C)** and **Student Fee Collection List Detail (R108-A)** reports did not print. In this release, one copy of the reports correctly prints for each contact marked **Copied on Correspondence**. In addition, if a student has contacts marked as **Copied on Correspondence**, the **Total Owed** no longer displays in the footer of the reports.
- (D3580) The **Student Fees Summary (R110)** report did not correctly filter results based on your selection(s) in the **Fee Type** multiselect list on the **Selection Criteria** screen. The report now filters the results correctly based on your **Fee Type** selection(s).
- (D9844) In a previous release, the **Payment Type** multiselect list was removed from the **Fee Payments By Accounting Code Detail** report **Selection Criteria** tab. Because this filter type is still needed, it has been added back to the report in this release.

Ad-Hoc Updates

- (D2918) Previously, on the **Student Fee Assignment** screen, if you selected to assign fees using the **Ad-Hoc Membership** method, fees were not assigned to students if you entered a **Fee Date** outside the course term date range. In this release, the fees are correctly assigned to the ad-hoc group.

Student GPA Ranking (R325)

- (D3123) The **Student GPA Ranking (R325)** report incorrectly included credits that were marked as GPA but did not have an associated point value. The report now correctly calculates and displays only credits used to calculate the GPA.

Student Registration Wizard

- (D8981) When you registered a student, the **Admitted From IRN** field on the **Complete Registration** tab of the **Student Registration Wizard** was incorrectly disabled and set to ********* if you selected an **Admission Reason** of **3 - Student transferred from nonpublic school in Ohio** or **6 - Transferred from other Ohio public district/community school**. In this release, when you select one of these **Admission Reason** values, the **Admitted From IRN** field is blank and enabled.

Student Course History Summary

- (D3660) Previously, JVS courses marked as **In Honor Roll** on the course record **Marks** tab did not display as **In Honor Roll** when they were imported into the home school, although the marks were still included in honor roll calculations. In this release, when you import JVS course history marks designated as **In Honor Roll**, the marks correctly display as **Include in Honor Roll** on the **Student Course History Summary** screen in the home school.

Assessment Imports

- OAA and OGT alternate assessment Social Studies score imports for FY15 and beyond now use the following ranges to determine placement levels:

Grade	Basic	Proficient	Accelerated	Advanced
3-5	376	400	436	466
6-8	381	400	430	475

Student Assessments

- The **Assessment Area** drop-down list on the **CTE Industry Credential** screen has been updated to remove outdated assessment areas and add new required assessment areas for FY15.
- On the **AP Exam Scores** screen, **Physics 1** and **Physics 2** have been added to the **Subject** drop-down list for FY15.

Resolved Issues

Verify Student Demographics

- (D10121, D10088, D9916) On the **Verify Student Demographics** screen, when an error displayed following the verify process and you clicked the student name link to enter a missing value on the **FN-Attributes** tab of the student profile, an error occurred stating that at least one of the **Racial Group(s)** on the **General** tab must be selected when the **Hispanic/Latino** field on the was set to **Y** or **N**. Even if you completed these values, they did not save to the database, and the error continued to occur. In this release, values that you update via the student name link save correctly.

Assessment Reporting Collection (A)

- (D10182) When you transferred WorkKeys (WK) assessment data, the scores in the transfer file were incorrectly left-justified, which caused error during reporting. Now, the scores are correctly right-justified with leading zeros or leading spaces.

Assessment Imports

- (D10177) Previously, a database error occurred if you imported SAT scores including students who had not taken an SAT Reasoning test and had no SAT Reasoning score in the import file. Now, you can import SAT files successfully even when a student has no SAT Reasoning score.
- (D10180) When you imported OAA and OGT alternate assessment scores, 4th and 6th grade Social Studies scores were not imported. In this release, the scores are imported correctly.

Student Assessments

- (D10173) Previously, an error occurred on the **CTE Student Assessment (OCTCA)** screen **CTE Portfolio Score** tab if you tried to save a **CTE Teaching Professions Portfolio Score** value other than 000-100. Now, you can successfully save any valid value in this field. (Valid values are 000-100, ***, I, N, P, and A.)
