## Enhancements

### Pre-Identification Export

- The **Pre-Identification Export** screen has been restyled for all export options. (*ProgressBook StudentInformation Import Export Guide*)
- Because the State of Ohio is no longer using certain assessments, on the **Pre-Identification Export** screen, the **Preident for PARCC** and **Preident for Ohio Online Field Test** options have been removed. (*ProgressBook StudentInformation Import Export Guide*)
- (E9693, E9893) On the **Pre-Identification Export** screen, the previous **Preident for AASWD and OCBA** option has been replaced with the following new options:
  - **Pre-Ident for AASWD and OCBA 3-8** – includes 3rd through 8th grade students taking the assessment(s) selected
  - **Pre-Ident for AASWD and OCBA HS Export** – includes high school students taking the assessment(s) selected

In addition, these export files now consistently include the name fields on the **General** tab of the student profile and no longer use the legal name fields on the **Private** tab.

- (E10189) The pre-identification export file for the KRA enrollment export now includes a new required first column called “data\_collection\_token” with a value of “kra2015” for each student. In addition, if you open the file in a text editor application (not in Excel), the district IRN values now contain leading zeros where needed.

### Master Calendar

- You can no longer add EMIS exceptions on the master calendar. You must add these on the sub-calendars exclusively. Scripts in this release will copy all of the EMIS exceptions from your master calendar to all of its sub-calendars.
- The **EMIS** section has been removed from the edit day version of the **Master Calendar** screen, and the **EMIS Exception Type** and **EMIS Exception Hours** columns have been removed from the add day version of the screen. ## Calendar Dates Wizard

- The **EMIS Exception Type** and **EMIS Exception Hours** columns have been removed from the **Configure and Confirm Boundary Changes** tab of the **Calendar Dates Wizard**. In addition, the **EMIS Exception Type** and **Hours** options and the **EMIS Exceptions - Hours** column have been removed from the **Non-Attending Days** tab. *(ProgressBook StudentInformation Attendance and Calendar Guide)*

## Sub-Calendar Day Maintenance

- On the add/edit version of the **Sub-Calendar Day Maintenance** screen, you are no longer required to either select an **Arrival Time/Departure Time** or make a selection in the **Periods of the Day** in order to save the screen. *(ProgressBook StudentInformation Attendance and Calendar Guide)*

## Calendar Exception Management

- The following two new screens are available for creating non-attending day exceptions for both StudentInformation attendance and EMIS reporting purposes:
  - **Calendar Exception Management** – to create exceptions on an individual sub-calendar (available in two different paths):
    - i. **StudentInformation > EMIS > Calendar Reporting Collection (C) > Calendar Exception Management**
    - ii. **StudentInformation > Management > School Administration > Scheduling Administration > Calendar Exception Management**
  - **Calendar Bulk Exception Management** – to create exceptions on multiple sub-calendars (available in two different paths):
    - i. **StudentInformation > EMIS > Calendar Reporting Collection (C) > Calendar Bulk Exception Management**
    - ii. **StudentInformation > Management > School Administration > Scheduling Administration > Calendar Bulk Exception Management**

## Resolved Issues

### Student Search

- (D10208) When you performed a student search resulting in a large number of student matches and then put a student in context, performance was very slow as you navigated throughout the application. In this release, the performance issue has been corrected.

## Pre-Identification Export

- (D10212) An error previously occurred when you loaded the pre-identification export file for the KRA student export into the KRA system. Headers for columns C, R, and W have been updated to correct this issue.
- (D9792) The pre-identification export file for the AASWD and OCBA assessments did not previously include the EMIS subject codes 159950 for the American Government portion of the extract or 152300 for the American History portion of the extract. These EMIS subject codes have now been added to the export file.
- (D9777) Previously, if a student was enrolled in more than one building, and a building other than the student's **Primary Building** on the **Additional** tab of the student profile contained a course being included in the pre-identification export file for the AASWD and OCBA assessments, the export file excluded that student. In this release, students are included in the export file of the courses taken even if they are taking the courses in a building not marked as their primary building.

## EZ Query SIS Student Search

- (D10267) When you ran the EZ Query **SIS Student Search** and selected to include **Retained Status** in the output, students with a **Retained Status** value of \* were returned with incorrect blank values in that field. In this release, the FN transfer file has been updated to insert \* as the **Retained Status** when this field is blank.

### Verify EMIS Run Requests (CHECK\_EMIS)

- The **Verify EMIS Run Requests (CHECK\_EMIS)** screen includes a new **R** option in the **Reporting Collection** drop-down list so you can review process runs for the new Grad Progress Reporting Collection (R).

### Manual Exception Days

- The **Manual Exception Days** screen is no longer available in FY16 and beyond because a new **Calendar Exception Management** screen has been added to replace it. (*ProgressBook StudentInformation EMIS Guide*)

## Resolved Issues

### Verify/Update Course Terms & Class List - (L)

- (D10313) The Course and Class List (CLISEMIS/CTRMEMIS) update process did not create the course master, student course, and staff course records as expected because the process incorrectly submitted the records using the obsolete period N instead of the current reporting collection L. In this release, the process correctly updates these records.

### Edit Student Profile

- (D10260) Previously, if a student had an FS record with an effective end date occurring before the start of school, the nightly student attendance update process (ATTUPEMIS) updated the **Current Entity** attendance fields on the **FS-Attendance** tab of the student's profile with blanks instead of zeros. This caused an error when you tried to access that tab. In this release, the nightly process is corrected to update the **Current Entity** fields with zeros when there are no attendance days in the date range being updated, and no error occurs when you access the **FS-Attendance** tab.
