## Enhancement

### Security

- The data grid on the **Security** screen **Staff Member Schools** tab has been updated to list schools in descending order of school year, beginning with the current year.

---

## Resolved Issues

### Course Sections

- (D10923) Previously, with a school in context on the **Course Sections** screen, clicking **Search** caused the system to time out without generating a course list. Now, when using **Search**, you can successfully generate a list of all courses and sections with correct Filling counts.

### Report Card Formatter (R700)

- (D10946) Previously, community schools using **Report Card Formatter (R700)** could not upload report cards to permanent storage, or view previously stored report cards. With this release, community schools can upload report cards to permanent storage and successfully view them.

### Potential Course Conflicts Matrix (R403)

- (D10942) In StudentInformation version 15.3.0, an error with the **Potential Course Conflicts Matrix (R403)** report occurred and the report did not complete. The report now completes without error.

## Student Gifted Record

- The following changes have been made to the **Student Gifted Record** screen:
  - The statement **Notes: For students identified prior to 2000 with an unknown identified date, enter a date of 1/1/1900.** has been removed.
  - For records entered for the 2015-2016 school year and beyond, the **Identified Date** field no longer accepts the date **1/1/1900**.

## Student Gifted Education (GG) Transfer

- For records in fiscal year 2016 and beyond, the **EMIS Student Reporting Collection (S), Student Gifted Education (GG) Transfer** no longer uses **\*\*\*\*\*** as a valid date.

## KRA

- With a student in context, when adding an assessment result to the **KRA** screen on the **Student Assessment Menu**, you must enter a valid score between 0 and 999. When the **Score Not Reported** field is set to \* - **Option Not Applicable, Student took Test**, you can enter a test score in the **Score** field. If any other option is selected in the **Score Not Reported** field, the **Score** field is disabled, and no score can be entered.

## KRA (GO) Transfer

- New scoring changes to the KRA assessments are now reported in the **EMIS Assessment Reporting Collection (A), KRA (GO) Transfer**.

## WorkKeys

- On the **WorkKeys** screen on the **Student Assessment Menu**, with a student in context, you must enter a valid score between 0 and 999 when adding an assessment result.

## WorkKeys (WK) Transfer

- New scoring changes to the WorkKeys assessments are now reported in the **EMIS Assessment Reporting Collection (A), WorkKeys (WK) Transfer**.

## Preschool ECO (GM) Transfer

- The **EMIS Assessment Reporting Collection (A), Preschool ECO (GM) Transfer** has been updated to search for assessments from an entire year, starting July 1 of any calendar year and ending June 30 of the next calendar year.

## Preschool ELA

- The following changes have been made to the **Preschool ELA** screen on the **Student Assessment Menu**:
  - Two assessments have been deleted: Emergent Writing and Classification.
  - The assessment for Phonics and Letter Recognition has been renamed to Phonological Awareness.
  - Three new assessments have been added for fiscal year 2016 and later:
    - Relationships with Adults
    - Vocabulary
    - Number Sense

- Previously, on the **Preschool ELA** screen, for testing dates in fiscal year 2015 or earlier, the **Score** fields allowed only numbers between 0 and 99 to be entered. With this release, if the testing date is in fiscal year 2016 or later, the **Score** fields allow only single character scores of 1,2,3,4,5,A,B,C,D,N (upper or lower case). The score \*\*\* is still valid when the **Score Not Reported** field lists **S - Non-Scorable Assessment**.

## Preschool ELA (GB) Transfer

- The following changes have been made to the **EMIS Assessment Reporting Collection (A), Preschool ELA (GB) Transfer**:
  - ELA records dated 2015 and earlier can still be edited.
  - ELA records dated 1/1/2016 and later no longer have scores for Emergent Writing or Classification.
  - ELA records dated 1/1/2016 and later now have scores for Phonological Awareness instead of Phonics and Letter Recognition.
  - ELA records dated 1/1/2016 and later have assessments for these new subjects:
    - Relationships with Adults
    - Vocabulary
    - Number Sense
  - The **Assessment Collection Preschool ELA (GB) Transfer** continues to transfer assessments for 2015 as well as the new assessments for 2016.

## International Baccalaureate (IB)

- Three new assessment areas have been added to the **International Baccalaureate (IB)** screen on the **Student Assessment Menu**:
  - IB91 – Global Politics HL/SL
  - IB92 – Global Politics HL
  - IB93 – Global Politics SL
- The **EMIS Assessment Reporting Collection (A), International Baccalaureate (IB) Transfer** has also been updated to report these new assessments.

## Resolved Issues


### CTE Industry Credential

- (D10934) Currently, when adding certain CTE codes to a student record with the 2015-2016 and 2016-2017 school years in context, the codes do not save to StudentInformation. To work around this issue, districts can place the 2014-2015 school year in context and add the CTE code to a student's record using the current test date. The record saves and is included in the transfer file to the data collector. Some of the affected codes include the following list (there may be additional codes affected):
  - CL04 – CL06
  - CCH83 – CH90
  - Some CJ codes

### FA Transfer

- (D9022) Previously, when a student took multiple ACT tests in the same month for a given year, only one ACT record could be added to StudentInformation for that month. With this release, you can now add multiple ACT records for the same month. The **FA Transfer** file now recognizes when there are multiple ACT assessments for a student for the same month/year. However, only one report is created for each month. The report selects the highest score from the multiple records for each assessment area.

### End of Course Exam

- (D10661) Previously, on the **End of Course Exam** screen of the **Student Assessment Menu**, if an accommodation of Y1, Y2, or Y3 was selected for an exam, and the teacher then clicked  to edit the assessment result, the **Accommodations** field on the edit window displayed **NO**. This caused the record to report erroneously to the **FA Assessment** transfer file. This field now correctly reports the accommodation selected on the **Add Assessment Result** window.

## Student Reporting Collection (S)

- (D10110) Previously, while transferring **Student Reporting Collection (S)** records for **Discipline (DISCEMIS)**, the operation timed out and did not complete for some districts. With this release, the procedure is improved and completes successfully.

## College Credit Management

- (D10006) Previously, when you manually entered courses on the **Student Course History** screen for new students and saved a dual credit course for a year in which the student was not enrolled, the course did not display on the **College Credit Management** screen. Now, a dual credit course saved on the **Student Course History** screen correctly saves in StudentInformation Ad-Hoc Updates and can be viewed on the **College Credit Management** screen **Manually Entered Courses** tab.

## Edit Student Profile

- (D9733) Previously, when a student who was registered with a non-default calendar was withdrawn and re-registered using a new calendar, and then the user attempted to revert the student profile to the previous calendar using the **Default Attendance Calendar** on the **Edit Student Profile** screen **General** tab, the admission history was deleted. In these circumstance, the admission history is now retained.
- (D10851) Previously, under some circumstances, the **School Year Attendance Hours** and **School Year Excused/Unexcused Absence Hours** on the **FS Attendance** tab calculated a negative number. The associated report, **Verify/Update - Student Attendance (ATTUPEMIS)** on the **Student Reporting Collection (S)** screen, now correctly calculates the hours attended.
