District Roster for Medicaid Billing

• (E11102) In the District Roster for Medicaid Billing export, the building codes and building IRNs from columns M and N have now been replaced with the latest active IEP start date and end date within the current year. Now, this export should be run in the current year instead of a prior year. (*ProgressBook StudentInformation Import Export Guide*)

Resolved Issues

Print Function

• (D11194) Previously, when you printed from certain StudentInformation screens, the enlarged font size resulted in multiple printed pages instead of a single page. Now, the correct font size enables you to print information on a single page for those screens.

Student Search

• (D11251) Previously, in web browsers Chrome and Firefox, when a Student Search returned only one result, the student was not automatically put into context. Now, the student is automatically put into context.

Student Fee Details

• (D11197) Previously, when you tried to print a student's **Student Fee Details**, an error occurred. Now, the **Student Fee Details** print with no error.

Time Fields

• (D11292) Previously, when you entered a time field using only numbers, it did not automatically convert as it should (e.g. entering 1415 and converting to 2:15 P.M.). Now, the time fields convert correctly.

WebXam Export

- For school years 2016-2017 and later, WebXam Export now includes the student's SSID.
- **WebXam Export** now includes a Teacher ID column that contains the corresponding teacher's State Staff ID.
- The Include Tech Prep Completer Students without CTE Program of Concentration check box has been removed to reflect new reporting requirements.
- WebXam Export now includes students whose State Equivalent Grade Level from the current FD record is 7th or 8th grade.
- The **Ad-Hoc Selection** and **Filter Selection** tabs no longer display messages indicating the grade levels included in the export.
- WebXam Export files can now be exported as Excel Spreadsheet (.xlsx) or CSV (.csv).
- In the Filter Selection tab, when you select Use Teacher of Record from applicable courses, results will only display if the student's course has a curriculum code that starts with "V" and the EMIS subject criteria and CTE program of Concentration selected are also met.

Pre-Ident for End of Course Exam Export

- The **Pre-Ident for AASWD and OCBA HS Export** is now renamed **Pre-Ident for End of Course Exam Export**.
- All occurrences of AASWD (Alternate Assessment for Students with Disabilities) are now renamed AASCD (Alternate Assessment for Students with Significant Cognitive Disabilities).
- The Separate Files for AASWD and OCBA check box is now renamed Create Separate File for AASCD. Selecting this check box still creates separate export files for AASCD and OCBA.
- **Pre-Ident for End of Course Export** files are now formatted as .csv files instead of .txt files.
- (E10937) The course section selectors are now filtered by EMIS subject codes.

- (E10817) The course sections selection window now displays the message, "Students enrolled in the course sections selected below will be included in the Pre-Identification export file."
- (E10797) Now, in the course sections selection window, you can choose if the Test Taken was on Paper or Online. This selection always defaults to Online.

- The Separate Files for AASWD and OCBA check box is now renamed Create Separate File for AASCD. Selecting this check box still creates separate export files for AASCD and OCBA.

Pre-Ident for End of Course Exams
