Resolved Issues

Edit Student Profile

(D11277) Previously, on the Edit Student Profile screen, with a student in context, when
you clicked on the FD-Attributes tab, the screen automatically scrolled to the bottom.
Now, when you click the FD-Attributes tab or switch to another student with the tab in
context, the screen stays at the top.

ACT Scores

 (D10892) Previously, on the ACT Scores screen, the Progress Toward Career Readiness drop-down list incorrectly listed NRCR. Now, the drop-down list correctly lists NCRC.

Portal Documents

 (D11260) Previously, on the portal, after adding a new document via URL to Browse, when you tried to access it, you received the error File Not Found On System Or Access Denied. Now, you can access new URL to Browse documents on the portal without receiving an error.

Feedback Form

- (D11307) The DASL Feedback Form window is now renamed Feedback Form.
- (D11307) Previously, after you submitted a feedback form, the messages, "Your feedback has been submitted. Thank You!" and "Thank you for your feedback about the DASL application. Please complete the form below and click on the Send button to send this information to your ITC support representative" displayed with a **Send** and **Cancel** button below. Now, after you submit a feedback form, the message, "Thank you for your feedback about the Student Information application" displays with a **Close** button below.

Class List Formatter (R703)

(D11093) Previously, when you ran the Class List Formatter (R703), if a student had an
inactive primary contact, the student displayed twice in the report. Now, students with
inactive primary contacts only display once.

Transcript Formatter (R702)

• (D11335) Previously, when you ran the **Transcript Formatter (R702)** with a format that used the CourseDifficultyCode keyword, an error occurred. Now, the **Transcript Formatter (R702)** runs successfully regardless of the format or keyword used.

KRA

- Error Band scores are no longer required for KRA assessments.
 - Now, when you enter or edit a KRA assessment, if an Error Band score is entered as
 or changed to a blank, you can save without error. Changing an Error Band score to
 blank overrides the original score.
 - Now, the add KRA assessment window sorts the scores in this order:
 - Language Literacy
 - Mathematics
 - Physical Development
 - Social Foundations
 - Overall Individual Student Report
 - Language Literacy Error Band
 - Mathematics Error Band
 - Physical Development Error Band
 - Social Foundations Error Band

APPTUPEMIS

When you report the hours that a student attended or missed using the EMIS FS Transfer, ATTUPEMIS now includes the absences entered outside the range of the master calendar to calculate the attending and absent hours accordingly.

Registration Wizard

- Now, on the Student Registration Wizard screen Registration Pre-requisites tab, you can select the Student is a Non-Attending Graduate check box to indicate that the student is a non-attending graduate (Grad-Only). Upon selecting this check box and clicking Next, the registration wizard enters Grad Only Registration Mode.
 - Non-Attending Graduates (Grad-Only) students can only be registered at community schools and traditional schools.
 - Transfer students can not be registered as Non-Attending Graduates (Grad-Only).
 - Now, if a previously withdrawn student is registered as a Non-Attending Graduate (Grad-Only) student, their **Diploma Type**, **Graduation Date**, **Expected Graduation**

Date, **Courses Completed IRN**, and **Courses Completed Date** update according to set Grad-Only parameters.

- Now, only for Non-Attending Graduates (Grad-Only) students, the FN-Graduate tab now includes the fields Courses Completed IRN and Courses Completed Date.
- Now, only for Non-Attending Graduates (Grad-Only) students, the **General** tab and **FN-Graduate** tab display the notification, "This Student is a Non-Attending Graduate."
- On the FS-Standing tab, the EMIS Situation drop-down list now includes EMIS
 Situations 600 Grad Only Student, Not Enrolled for traditional districts and 601 Grad
 Only Student, Not Enrolled for community schools.

Assessment Transfer - Collection (A)

- Now, when FY2016-2017 or any FY forward is in context, KRA (GO) transfer files no longer include Error Band scores even if they exist for a student.
- Now, Non-Attending Graduates (Grad-Only) students are excluded from all Collection A processes.

Grad Progress Transfer – Collection (R)

 Now, Non-Attending Graduates (Grad-Only) students are excluded from all Collection R processes.

EMIS – Verify/Update and Transfer Period (G)

- Now, the Period G **Verify Student Ohio Graduation Test** process includes Non-Attending Graduates (Grad-Only) students.
- Now, the Period G Verify Graduate Demographics / Attributes process checks the Diploma Date and Diploma Type reported for errors for Non-Attending Graduates (Grad-Only) students.
- Now, the Transfer Student Graduate Demographics / Attributes process includes the elements Courses Completed IRN and Courses Completed Date for Non-Attending Graduates (Grad-Only) students.
- (E11378)Now, all assessment transfers send End of Course records that the student took in any year, not just the year in context.
 - (E11377) Students registered through the new Grad Only process who have End of Course Assessment Records are now included in the Period G Assessment Transfer, as well as their records from prior years if they were enrolled in the district and have End of Course Assessment Records.
- Now, when FY2015-2016 or any FY forward is in context, Transfer Student
 Graduation-Only Test Record is no longer a selectable option as Grad Only data is
 collected using Graduate Attributes (FN), Demographics (GI), Ethnicity (GJ), and
 Assessment Transfers.
- Now, the Verify/Update Graduate CORE Summary process calculates CORE Summary records for Non-Attending Graduates (Grad-Only) students if they have a course history record that is high school credit. If the Non-Attending Graduates

- (Grad-Only) student does not have any course history records that are high school credit, existing manually-entered records are not deleted or altered.
- Now, Non-Attending Graduates (Grad-Only) students are included in all Period G transfers.
 - Any assessment records for Non-Attending Graduates (Grad-Only) students are included in all Period G FA transfer files if their enrollment date is between the first day of school and the day before the first day of school of the upcoming school year.

Staff/Course Transfer – Collection (L)

 Now, Non-Attending Graduates (Grad-Only) students are excluded from all Collection L processes.

Student Transfer - Collection (S)

- Now, Non-Attending Graduates (Grad-Only) students are excluded from all Collection S processes.
- Now, the Transfer Student Attributes No Date (FN) process includes the elements Courses Completed IRN and Courses Completed Date for Non-Attending Graduates (Grad-Only) students.

EMIS Situations

• (E11373,11365) A script has been provided for an update regarding Preschool EMIS Situations. Students in ECE, regardless of the resident district, are to have "E" reported for the How Received Element. The script updates the How Received Element for eligible students to "E." The script also updates the ELPA mode column to the correct position on the Pre-Identification file for Next Generation, End of Course, and OELPA assessments.
