Resolved Issues

Course Section Assignments

• (D11193) Previously, when you added or transferred an assignment, the new record was difficult to identify when you were prompted to **Save Changes**. Now, new records are colored orange to distinguish them from others.

Portal – Documents

 (D11474) Previously, in the Portal – **Documents** section, you received an error when you tried to open a document that was uploaded to the web server. Now, you can open these documents successfully.

Enhancements

UNCLEMIS

- (E7222) The Student Verification (UNCLEMIS) "FN07E High school student is missing Fiscal Year Began 9th Grade" error is no longer received for students who are summer withdrawn.
- (E10997) The UNCLEMIS process no longer validates School Year Attendance Days, Absence Days, or Unexcused Absence Days as these fields are no longer used for EMIS reporting due to attendance being reported in hours instead of days.

Assessment Transfer – Collection A

 (E11444) The FA Assessment Transfer for the Preschool ELA (GB) EMIS Transfers now includes all assessment records that have test dates within the 07/01/XX through 6/30/XX fiscal year.

Resolved Issues

UNCLEMIS

- (D11273) The Student Verification (UNCLEMIS) FD16E "Preschool Student cannot have Sent to Reason (1 or 2) or OE or 64" error has been disabled. Effective FY17, preschool students can be reported with any EMIS situation that is valid for school aged students.
- (D11467) The Student Verification (UNCLEMIS) "Sent to IRN has an invalid Postsecondary IRN specified (E)" smart error has been updated to: "Sent to IRN has an invalid College Credit Plus IRN specified."
- (D9467) The Student Verification (UNCLEMIS) "AH02W Student has Overlapping Admission History Records" error has been updated to appear in each of the buildings where the conflict exists. Previously, the error was received only in the building where the student had an active status.

Transcript Formatter (R702)

• (D11433) Previously, students with duplicate performance levels had duplicate End of Course Assessments on the created transcript. Now, transcripts are created properly with no assessment duplicates.

Student Withdraw

 (D3333) Previously, when you withdrew a student who had been withdrawn and re-enrolled in the current year, you received the error message, "The student was successfully withdrawn, but Admission History and EMIS Student Standing do not agree." Now, the message is only received if the student is withdrawn and the FS record prior to the latest FS record is also set as Withdraw.

Student Transfer – Collection S

(D11422) The Period S Student Contact Address (FG) Transfer has been updated to include the SOES Historical Address when the Legal District of Resident Change Date is in the current fiscal year; for example, for FY17 7/1/16 - 6/30/17. SOES Historical Addresses with dates outside of the current fiscal year are excluded in the transfer.

EMIS – Verify/Update and Transfer Period (G)

• (D11497) Previously, when a student had more than one GW record for the same assessment area, the transfer file included all records as duplicates. Now, only one record is submitted to indicate the assessment was taken.

Registration Wizard

 (D11466) Previously, when you used the Registration Wizard to transfer a student and did not select the I don't want to transfer course history, attendance records and assessments check box, you received the error, "You must map 'Receiving Marks' before 'ADD." Now, the error does not occur.

EMIS Situations

• (11564) Students with **EMIS Situation** 395 and 396 with a **How Received** of "E" now have their **How Received** updated to "*" according to ODE requirements.
