Enhancements

Graduation Points

- Users with the appropriate permissions can now access the new **Graduation Points** screen by clicking **Graduation Points** on the **Student Menu** screen. From here, users can access the **Grad Points Summary** and **Student Exemptions / Requirements** screens.
 - The **Grad Points Summary** screen displays the **Credit Requirements** and **Graduation Pathways** progress for the student in context.
 - The **Student Exemptions / Requirements** screen allows you to assign exemptions or requirements met to a student.

End of Course Exam

- (E11267) Now, assessments on the **End of Course Exam** screen are listed in chronological order. Additionally, the **Test Administration** column displays the calendar year of the Spring or Fall semester the assessment was taken instead of the Fiscal Year.

Student Search

- When you search for a student, the results list now displays the students' middle names.

Universal Access Icon

- The Disability icon has been replaced with a Universal Access icon  across the application. *(ProgressBook StudentInformation Student & Registration Guide)*

Courses

- On the **Courses** screen of the **Course Maintenance** menu, when you add or edit a course, under the **EMIS** tab, you can now associate that particular course to an **End of Course Assessment Area** from the drop-down list. (*ProgressBook Course History Class Rank Transcripts Guide*)
- A script is included in this release to automatically associate appropriate **Courses** to a corresponding **End of Course Assessment Area** based on existing EMIS codes.

Manually Entered Course

- When you add a **Manually Entered Course** on the **Student Course History Summary** screen, on the **Course Details** tab, after selecting a **Course**, you can now either click **Auto Populate** to automatically associate the corresponding **End of Course Assessment Area** based on your selected course, or manually select a different **End of Course Assessment Area** from the drop-down list. Resolved Issues

Course Section Mark Entry

- (D11343) Previously, when the name for **Marking Patterns** was too long, the Display Options did not display correctly. Now, the **Course Section Mark Entry** screen displays without error.

Student Mark Entry

- (D11343) Previously, when the name for **Marking Patterns** was too long, the Display Options did not display correctly. Now, the **Student Mark Entry** screen displays without overlapping the displayed values.

Student Marks

- (D11211) Previously, when a student was withdrawn or a course was dropped, the applicable course(s) were not highlighted on the **Student Marks** screen. Now, these courses are highlighted on the **Student Marks** screen.
- (D11408) Previously, long teacher names overlapped on the marks columns on the **Student Marks** screen. Now, the names do not overlap.
- (D11440) Previously, when you tried to print this screen with a long teacher name, it overlapped into the next column(s). Now, the name does not overlap in this situation.

Disability Alert

- (D11182) Previously, when a student was in context, assigned disability alerts entered in a year other than the year in context did not display the Disability icon. Now, the Universal Access icon displays correctly.

Student Profile — FS-Standing

- (D8456) Previously, when you changed a student's SSID, the record was not saving correctly. Now, student SSIDs save correctly when changed.

Registration Wizard

- (D10267) Previously, when you registered a new student, the **Retained Status** field on the **FN-Attributes** tab was incorrectly saving a Null value. Now, the Registration Wizard correctly saves the **Retained Status** field as the default "** - Student was not retained at the end of the previous school year."

Student Search

- (D11276) Previously, when you initially logged in with a building or district in context and tried searching for a student on the home screen, you received the error message: "You do Not Have Access to View the Requested Page." Now, you can successfully run a **Student Search** while on the home screen.

School Absences

- (D11695) Previously, after you added an **Absence** with a date range and selected the **Retain Values** check box, when you edited a different existing **Absence** and left the **Retain Values** check box selected before clicking **Save**, the edited **Absence** had its date range changed to the last date of the date range from the newly added student **Absence**. Now, in these circumstances, the date range for the edited **Absence** does not change to a different date.

Enhancements

New School Year Script

- The new school year script is included in this release.

EMIS Situations

- (E11636) A script has been provided for an update regarding Preschool EMIS Situations. The changes are also included in this release. The following Preschool EMIS Situation codes have been altered:
 - Situations **450** and **451** are now inactive.
 - Situations **404**, **405**, and **406** have been combined into “404 - PS Court Placed in Sending District PS ECE Grant at ESC.” Situations **405** and **406** are now inactive.
 - Situations **387** and **388** have been combined into “387 - PS ESC Providing Instruction and Related Services.” Situation **388** is now inactive.
 - Situations **391** and **392** have been combined into “391 - PS Head Start or Other Funding.” Now, the **How Received** value is * and Situation **392** is inactive.
 - Situations **395** and **396** have been combined into “395 - Resident PS Head Start or Other Funded PS.” Now, the **How Received** value is * and Situation **396** is inactive.

Assessment Transfer – Collection A

- From FY17 and forward, Period A no longer includes the option to transfer the CTE Industry Assessment (GU) records as they are no longer EMIS reportable.

- (E11378) From FY17 and forward, the Period A Assessment transfers to the Data Collector for the End of Course (GE) Assessments include all past year and present year End of Course records for each student.
- (E11542) From FY17 and forward, the Period A Assessment transfer to the Data Collector includes the ability to transfer the OELPA (F) assessment records.

- (E11374) From FY17 and forward, the **Test Date** for Next Generation Assessments taken in the Fall Testing Window is reported to ODE with a November test date, i.e. 201711, in the Period A Assessment transfer to the Data Collector.

Student Profile Bulk Update

- (E2322) The **Limited English Proficiency** field has been added to the **FS-Standing & FS-Attributes-Effect Date** tab. This process now allows you to update that value for the students as needed.

End of Course Exam

- (E11558) When you add an End of Course Exam result for a student, in the **Actual Year of Test** drop-down list, you can now select Fiscal Years 2013 and 2014.

Assessment Imports

- (E11542) The **Assessment Imports** screen has been updated to include an import for the OELPA assessment records. Once imported, these records can then be reported to ODE EMIS as expected. *(ProgressBook StudentInformation Assessment Guide)*
- (E10980) From FY17 and forward, imports for ACT assessments now follow the new record layout and are 1050 characters per row. Shorter file sizes from previous years, such as FY15 and FY16, still import properly.

Ohio English Language Proficiency Assessment (OELPA)

- (E11542) The **Ohio English Language Proficiency Assessment (OELPA)** screen has been added. OELPA records display here, and can be manually added or edited on this screen. *(ProgressBook StudentInformation Assessment Guide)*

ACT

- (E11556) When you manually add an ACT assessment for a student, the entry fields are now in the following order: **Composition, Math, Science, STEM, English, Reading, Writing Test Score, ELA, and Writing Domains**. *(ProgressBook StudentInformation Assessment Guide)*

Ad Hoc Reports

- When assigned the new AH-ITC role or Full Admin Ad Hoc Report roles, you can now access the **ITC** folder on the **Ad Hoc Reports** screen to run an **ITC Student Count Report** based on selected start dates and end dates. The completed report displays the **District IRN, District Name, Max Student Count Date**, and **Student Count** for each district in the ITC.
- The **Student Count Report District Detail** report is now available on the **Ad Hoc Reports** screen **Student** folder. The completed report displays the **School IRN, School Name, Max Student Count Date for the District**, and **Student Count** for each school in the district in context on the date that the district has had the highest student count.
- The **Student Count Report Student Detail** report is now available on the **Ad Hoc Reports** screen **Student** folder. This report displays each student that was counted by the Student Count Report within the district in context and includes the **School Name**,

Grade Level, Student Name (Last, First Middle), **Student Number, Birth Date,** and **Gender.**

- If you want to view more or different details for this report, you can edit this report (with sufficient role access) or create a new report with any combination of available **Student Count Report Student Detail Sort Fields.**
- Available **Sort Fields:** Birth Date, District Admission Date, District Withdrawal Date, EMIS Situation, Gender, Grade Level, Homeroom, Homeroom Start Date, Homeroom Stop Date, Homeroom Teacher (Last, First Middle), Percent Of Time, SchoolIRN, SchoolName, Sent To Reason, Student Name (Last, First Middle), and StudentNumber.
- (E11310) The **Ad Hoc Reports** screen now has two new folders: **Assessment** and **Vendor Extract.**

Resolved Issues

School Year Initialization

- (D10977) Previously, when you ran the School Year Initialization process, the **County of Residence** was not copied into the next year's **Registration Defaults.** The **County of Residence** value now copies to the next year correctly.

Assessment Imports

- (D11546,D11544) Previously, when you ran an ACT Import with an FY16 report layout, an Arithmetic Overflow error occurred. Now, when running the ACT import process for FY16 and forward, the import runs successfully as the report layout has been updated in the application.
- (D10853) Previously, when you ran an ACT or SAT Import, each record saved with the SchoolYearID of the year in context when you ran the import. Then, if you proceeded to import the same record with a different year in context, a duplicate record was created. Now, the ACT Import correctly saves records with a SchoolYearID that corresponds to the testing date in the import record.

Pre-Identification Export

- (D10967) Previously, when you ran a **Pre-Identification Export** for an End of Course Exam or Next Generation Assessment, some students were excluded because the process looked for FS/FD records to exist as of April 4th. Now, at the bottom of the **Pre-Ident For End of Course Exam Export** and **Pre-Ident For Next Generation Assessment Export** screens, a calendar displays the default run date set by your ITC on the **EMIS Defaults** screen. If you want to use a different run date, you can select it with the calendar. Students who are not enrolled by the selected or default run date are excluded in the export files. (*ProgressBook StudentInformation Import/Export Guide*)

EMIS Defaults

- (D10967) Previously, when you ran a **Pre-Identification Export** for End of Course Exam or Next Generation Assessment, some students were excluded because the process looked for FS/FD records to exist as of April 4th. A new screen, **EMIS Defaults**, is now accessible at the ITC level and allows you to adjust the default run date to include previously excluded students. On this screen, you can set the **End of Course Pre-ID Default Run Date** and **Next Generation Pre-ID Default Run Date** for the **Pre-Ident For End of Course Exam Export** and **Pre-Ident For Next Generation Assessment Export** screens respectively. UNCLEMIS

- (D11584) A script has been provided for an update regarding the UNCLEMIS FN07E error. The change is also included in this release.
- Previously, UNCLEMIS incorrectly returned FN07E for withdrawn students in grades 9-13 and 23 who had a **Fiscal Year Began 9th**. Now, UNCLEMIS only returns FN07E for students if they are missing **Fiscal Year Began 9th** regardless of their status for students in grades 9-13 and 23.
