Enhancements

Student Exemptions / Requirements

A script has been included to map student profile graduate exemptions to the corresponding exemptions and requirements on the student's **Student Exemptions / Requirements** screen for calculating **Graduation Points**. On a student's **Edit Student Profile** screen **FN Graduate** tab, if any of the drop-down lists for **CORE Economics and Financial Literary Requirement Met**, **CORE Fine Arts Requirement Met**, or **Exempted from Physical Education Graduation Requirement** have "Y" selected, the script automatically selects the corresponding check boxes on their **Student Exemptions / Requirement** screen.

Resolved Issues

Report Card Formatter (R700)

- (D11772) Previously, when you selected to view a student's report card from the **I Want To...** menu drop-down list, the latest report card did not display. Now, the latest report card displays correctly.

Student Medical Alerts

- (D11815) Previously, when **Student Medical Alerts** were updated from an Online Student Registration third party vendor, existing **Private Notes** associated with a **Student Medical Alert** were not erased or altered accordingly. Now, **Private Notes** update correctly in these circumstances.

Registration Wizard

- (D11799) Previously, if a student was transferred from another building in the same district, and you tried to enroll the student from the **View Pending Students** screen **Details** option, the student could not be successfully enrolled. Now, in these circumstances, you can successfully enroll the transfer student.

Enhancements

ATTUPEMIS

- (E11031) When calculating a **College Credit Plus** student's attendance hours, ATTUPEMIS now includes the combined **Full Time Equivalent** (FTE) from both **Percent of Time** indicated under **Sent to 1** and **Sent to 2** on the **Edit Student Profile** screen **FS-Standing** tab.

Pre-Ident for End of Course Exam Export

- (E11725) The courses that display in the selection window for each End of Course subject are now based on the selected **End of Course Assessment** value on the **Courses** screen **EMIS** tab.

Ad Hoc Memberships

- (E11398) You can now filter for students by their End of Course **Assessments in the following Date Range, Assessment Area, and Performance Level** when creating or editing Ad Hoc Memberships. (*ProgressBook Student Information Getting Started Guide*)

End of Course Exam

- (E11760) By default, the End of Course Exam grid now sorts records by **Test Administration** date (oldest to newest) and then by **Assessment Area** (alphabetical). You may now also sort the data on any column by clicking the column heading. (*ProgressBook Student Information Assessment Guide*)

Next Generation Assessment Grades 3-8

- (E11760) By default, the Next Generation Assessment grid now sorts records by **Test Administration** date (oldest to newest) and then by **Assessment Area** (alphabetical). You may now also sort the data on any column by clicking the column heading. (*ProgressBook Student Information Assessment Guide*)

Resolved Issues

CTE Industry Credential Records Script

- (D11759) The CTE Industry Credential Records Script inserts the missing **Assessment Areas** that display in the corresponding drop-down list when you add CTE Industry Credential records for FY17 and FY18

ATTUPEMIS

- (D11327) Previously, when students were enrolled in multiple districts and/or buildings, ATTUPEMIS did not calculate student absences from all buildings the student attended, which resulted in only half the day of absences being counted for students who attended two buildings 50 percent of the time each. Now, in these circumstances, ATTUPEMIS correctly calculates full day absences for students based on the **Reporting Calendar** on the student's **Edit Student Profile** screen **FD-Attributes** tab.
- (D11218) Previously, ATTUPEMIS rounded attendance percentages up to two decimal places before starting the calculation process, which caused certain attendance calculations to be higher than expected when the student's **Full Time Equivalent** was less than 100%. Now, ATTUPEMIS rounds attendance percentages up to four decimal places before calculating for more accurate reporting, and still rounds the final attendance percentage to two decimal places.

Pre-Ident For Next Generation Assessment Export

- (D11726) Previously, when you ran the pre-identification process for Next Generation Assessment using an Ad Hoc Membership with students who have changed buildings within a district, a data conflict error occurred. Now, in this situation, the process runs successfully.

ACT

- (D11809) A script has been included to clean up existing data for ACT records that have test categories from the wrong school years.

Ad Hoc Reports Widget

- (D11840) Previously, the **Ad Hoc Reports Widget** did not display reports from the **Assessment**, **Vendor Extract**, or **ITC** folders. Now, each user can run Ad Hoc Reports from these folders if they have appropriate access.

OELPA Assessment Imports

- (D11854) Previously, when you imported an OELPA file with blanks in positions 25-33, an error occurred. Now, in these circumstances, the OELPA file imports successfully.
