Enhancements

Assessment Extract

• (E11080) The **Assessment Extract** screen now lets you extract test results for CTEIND, DORP, OCTCA, and OELPA. (*ProgressBook StudentInformation Assessment Guide*)

Assessment Import

• (E11080) You can now import assessment extract files that contain test results for CTEIND, DORP, OCTCA, and OELPA. (*ProgressBook StudentInformation Assessment Guide*)

Transcript Formatter (R702)

• (E11532,E11404) The R702 transcript now displays the highest numeric performance level for each End of Course Assessment instead of the highest score.

Home School Export

• (E11519) Now, when you run the Home School Export, if a course has an **EMIS Location IRN** on its **EMIS** tab, the IRN is included in the export file. Otherwise, the export includes the IRN of the building in context. (*ProgressBook StudentInformation Import Export Guide*)

Grad Points Summary

 (E12205) On the Grad Points Summary screen, the 2017 Requirements tab for graduation now only displays for students who have a Fiscal Year Began 9th value of 2014 or earlier on their Edit Student Profile screen FD-Attributes tab. (ProgressBook StudentInformation Graduation Points and Eligibility Guide)

Resolved Issues

Manually Entered Courses

• (D11950) Previously, when you changed the **Rank Weight** field on a manually entered course and clicked **Save**, you received a confirmation message but the **Rank Weight** field did not retain the new value. Now, in these circumstances, the **Rank Weight** field saves correctly.

INFOHIO Export

 (D11916) Previously, if a student's primary contact was deleted, when you ran the INFOHIO Export, the export file contained two records for that student: one with the deleted primary contact and one with the new primary contact. Now, in these circumstances, only one record for the student with the new primary contact displays in the export file.

Report Card Formatter (R700)

- (D11957) Previously, when a student had an inactive primary contact with the same **AddressId** as the active primary contact, duplicate report cards were created when you ran R700. Now, report cards are only created for the active primary contact when you run R700.
- (D8394) Previously, when you ran R700 with the **Include Copied on Correspondence** check box selected, additional copies were generated for inactive contacts that were marked **Copy on Correspondence**. Now, no additional copies are generated for inactive contacts marked **Copy on Correspondence**.

Graduation Points

- (D12171,12196) Previously, when a student was prorated in 6 subject areas and did not meet the 5 point requirement across ELA2 and GEOM/MTH2, an error occurred. Now, in these circumstances, the relevant Graduation Points screens correctly display the student's progress towards the 5 point requirement.
- (D12074) Previously, when a student had an End of Course Exam with "Y" selected in the Score Not Reported field and "***" in the Score field, the Performance Level points entered on the record were included in the State Assessment Pathway points total. Now, the Performance Level points entered on a record with a Score Not Reported field value of "Y" are ignored, and the State Assessment Pathway total points required are reduced by 3 points. For additional records with a Score Not Reported field value of "Y," the required points are further reduced depending on how many assessment subjects were transferred into the district.
- (D12118) Previously, when a student attended a home school that shared an IRN with another building in the home district, even if a District Trust for Grad Points was enabled, the Home School tab did not display on the Grad Points Summary screen for the JVS. Now, even if an IRN is shared between multiple buildings, both the Home School tab and JVS tab display.

Student Data Tasks

 (D12138) Previously, on the Student Data Tasks screen, when you ran the Copy Transportation Assignments process and the Parking Permit or bus Number fields contained more than 4 characters, an error occurred. Now, the process runs successfully.

Discipline Incidents

 (D11336) Previously, after installing a new version of StudentInformation, the Add/Edit incident screens for discipline incidents did not load properly without users clearing their browser cache. Now, the Add/Edit incident screens load without error.

Student Requests

(D12206) Previously, when a course record was saved with or without any changes, any students that had a request for that course had the request Priority updated to match the Scheduling Priority field on the course record. Now, the course request Priority field does not change unless the Scheduling Priority field is updated on the course record and the Priority of the request matches the previous Scheduling Priority of the course.

Enhancements

Assessment Transfer - Collection (A)

- (E11951) From FY17 and forward, the Period A **Transfer OGT (GX)** process now no longer includes writing alternate (ALT) assessments. Standard (STR) OGT writing assessments are still transferred.
- (E11951) From FY17 and forward, when a student does not have a writing alternate assessment but has completed other OGT writing assessments, the Period A Verify OGT (GX) process now no longer displays the message, "Student is missing required test record for test part Writing."
- (E11214) From FY17 and forward, the Period A **Transfer SAT (SA)** process now includes the actual date, month, and year the SAT scores were earned.
- (E11214) From FY17 and forward, the Period A **Transfer ACT (AC)** process now includes the actual date, month, and year the ACT scores were earned.
- (E12110) From FY17 and forward, the Period A Transfer DORP Growth (MAP) (GD) process now only includes assessments taken within the Fall Window Assessment period (August – November) and Spring Window Assessment period (March – June).
- (E12109) From FY17 and forward, the Period A Transfer Preschool ELA (GB) process now only includes assessments taken within the Fall Window Assessment period (August – November) and Spring Window Assessment period (February – May).
- (E12245) All preschool students are now included in the Period A Verify KRA (GO) process regardless of their LEP status.

EMIS – Verify/Update and Transfer Period (G)

- (E11214) From FY17 and forward, the Period G **Transfer SAT (SA)** process now includes the actual date, month, and year the SAT scores were earned.
- (E11214) From FY17 and forward, the Period G **Transfer ACT (AC)** process now includes the actual date, month, and year the ACT scores were earned.
- (E11214) The Period G **Transfer CTE Industry Credential (GW)** process now includes the date, month, and year the assessment was taken instead of only January of the year it was reported.
- (E11565) The Period G **Transfer EMIS Data (G)** process now includes the **Transfer - WorkKeys (WK)** option. (*ProgressBook StudentInformation EMIS Guide*)

ACT

• (E12159) Now, when you manually add ACT assessment records, you may select the appropriate value from the **Score Not Reported** drop-down list for students who are exempt from taking the ACT.

Childhood Outcome Summary (COS)

• (E11955) All instances of Early Childhood Outcome (ECO) in the application are now renamed Childhood Outcome Summary (COS). (*ProgressBook StudentInformation Assessment Guide, ProgressBook StudentInformation EMIS Guide*)

CTE Industry Credential

• (E11214) You can now add and update CTE Industry Credential assessments with the day, month, and year the credential was earned instead of only the month and year. (*ProgressBook StudentInformation Assessment Guide*)

DORP Growth (MAP)

 (E12110) The valid assessment dates for the DORP assessment are now August – November for the Fall Window Assessment and March – June for the Spring Window Assessment.

End of Course Assessments

• (E11936) You can now add End of Course assessments with a **Fiscal Year of Test** of 2012.

Preschool ELA

- (E11066) From FY17 and forward, when you add or view a Preschool ELA assessment, the subject areas now display in the same order as they do on the manual entry Bridge forms. (*ProgressBook StudentInformation Assessment Guide*)
- (E12109) From FY17 and forward, the valid assessment dates for the Preschool ELA assessment are now August – November for the Fall Window Assessment and February – May for the Spring Window Assessment.
- (E11146) The Preschool ELA screen now displays assessment results with the most recent test scores listed first. (*ProgressBook StudentInformation Assessment Guide*)

SAT

• (E12159) Now, when you manually add SAT assessment records, you may select the appropriate value from the **Score Not Reported** drop-down list for students who are exempt from taking the SAT.

Assessment Import

- (E11951) From FY17 and forward, the alternate OCBA assessment import no longer creates an OGT Writing record.
- (E12040) You can now import Preschool ELA assessments. (*ProgressBook StudentInformation Assessment Guide*)
- The **Assessment Type** drop-down list now displays all supported assessment imports in alphabetical order. (*ProgressBook StudentInformation Assessment Guide*)

Membership Groups

• (E12002) Memberships with the **405011** membership code and **Other** membership name are now renamed **Other Academic Extracurricular Activities**.

Edit Student Profile

- (E12112) On the Edit Student Profile screen FD-Attributes tab, the Homeless Unaccompanied Youth field is now renamed Unaccompanied Youth. For FY17 and forward, you can no longer select * for this field. (*ProgressBook StudentInformation Student and Registration Guide*)
- (E12112) A script has been included in the release to update all **Unaccompanied Youth** values from * to **N** for FY17 and forward.

UNCLEMIS

- (E12112) The Student Demographic Verification (UNCLEMIS) process has been updated to remove the following errors to accommodate the new requirements for the **Unaccompanied Youth** field:
 - FD13E If the Homeless Status '*', then Homeless Unaccompanied Youth status must be '*'.
 - FS14E If the Homeless Status not '*', then Homeless Unaccompanied Youth status must be not '*'.
- (E12112) From FY18 and forward, the UNCLEMIS process now checks for the error "FD18E - ERROR: Unaccompanied Youth Status cannot be '*', must be Y or N."

MAJOREMIS

- (E12281) The Student Majority of Attendance IRN Verification (MAJOREMIS) process has been updated to include the following EMIS subject codes for the **9th prior to FY15** tab:
 - 150300 Government
 - 150308 Government/Economics
 - 159950 Government & Politics
 - 150810 History (American)
 - 152300 History (Integrated)

Fall Initialization

- (E12113) When you run the Fall Initialization Update process, you can now select the Set Unaccompanied Youth Status to "N" check box to reset the value of Unaccompanied Youth to N for all students. (*ProgressBook StudentInformation ITC EMIS Guide*)
- (E12113) When you run the Fall Initialization Update process, the Set Homeless Status and Homeless Unaccompanied Youth to Not Applicable (*) check box is now Set Homeless Status to Not Applicable (*). (*ProgressBook StudentInformation ITC EMIS Guide*)
- (E11523) The Fall Initialization process now copies the CTE Program Area and CTE Program of Concentration fields in the FN-Attributes tab from one school year to the next year. (*ProgressBook StudentInformation ITC EMIS Guide*)

District and Building Information

- (E11372) From FY17 and forward, the District and Building Information screen District Organization Info (DN) tab has a College Credit Plus Student Denied Participation/Student Billed section. The following attributes should be entered for inclusion in the Period S Transfer - Organization - General Information (DN) process:
 - Enter the count of CCP students denied participation because they did not give notice of CCP participation by the deadline date.
 - Enter the count of students who failed or dropped a course where districts sought reimbursement from the student for the cost of the course.
 - Enter the total dollar amount a district is seeking for CCP reimbursement due to a dropped or failed course for all students.

 (E11919) From FY17 and forward, on the District and Building Information screen District Organization Info (DN) tab, the District Transportation section is no longer available. (*ProgressBook StudentInformation EMIS Guide*)

Student Transfer - Collection (S)

- (E11372) From FY17 and forward, the Period S Transfer Organization General Information (DN) process now includes data from the College Credit Plus Student Denied Participation/Student Billed section on the District and Building Information screen District Organization Info (DN) tab.
- (E12117) The Period S **Transfer Student Missing Override (FC)** process is now renamed **Transfer Student Withdrawal Override (FC)**. (*ProgressBook StudentInformation EMIS Guide*)

CTE Student Assessments (OCTCA)

• (E12184) For FY17 and FY18, the GY Assessment codes in the **CTE Student Assessment Code** drop-down list have been updated according to new reporting requirements.

CTE Industry Credential

• (E12184) For FY17 and FY18, the GW Assessment codes in the **Assessment Area** drop-down list have been updated according to new reporting requirements.

Student Withdrawal Override (FC)

- (E12117) For FY17 and forward, the **Student Missing Override** screen is now renamed **Student Withdrawal Override (FC)**.
- (E12117) For FY17 and forward, the **SSID** field for Student Withdrawal Override (FC) records is now renamed **State Student ID Previous Reporting Year**.

Resolved Issues

Pre-Ident for End of Course Exam

• (D11976) Previously, when you ran the Pre-Ident for End of Course for multiple buildings with the same course sections selected and without any Ad Hoc Memberships selected, an error occurred. Now, in these circumstances, the export runs successfully.

Next Generation Assessment Grades 3-8

 (D12226) Previously, when you added an ELA assessment for any grade level with a Period of Test of Spring and a Fiscal Year of Test of 2017, the assessment incorrectly saved as a Fall Block - 2016 record. Now, in these circumstances, the ELA assessments save correctly.

Teacher History Maintenance

• (D11252) Previously, after you selected buildings and performed the **Wipe And New** or **Add Missing** option successfully, this error message incorrectly displayed: "Select at least one building to update." Now, in these circumstances, the error message does not display.

Assessment Import

- (D11755) Previously, when you imported a KRA file, if some of the records in the file had "ERROR" in their fields, the import failed. Now, in these circumstances, the file imports successfully and users receive an error message on the **Errors** tab of the **Assessment Import Management** screen.
- (D11165) Previously, when you imported OCBA assessment records, assessments with a Test Type of "ALT - Alternate" did not have Accommodations value set to "NO." Now, in these circumstances, the Accommodations value is set to "NO."

OEDS IRN Search Q

• (D12090) Previously, in the application, when you clicked **Q** to search for an IRN on the OEDS (Ohio Educational Directory System) website, an error occurred. Now, you are taken to the correct search URL.

CTRMEMIS

- (D11993) Previously, when you ran the Course and Class List Verification (CTRMEMIS), you incorrectly received the "Error 51: The course section does not have a teacher history record for a specific time" error due to an incomplete JOIN. Now, the verification process runs correctly.
- (D12039) Previously, when you ran the Course and Class List Verification (CTRMEMIS), values from the EMIS Override tab occasionally did not update correctly due to course sections having more than one EMIS Override record. A script is included in this release to delete all duplicate EMIS Override records so that only one exists per course section. Now, you can no longer create duplicate EMIS Override records for each course section.

Note: A script was sent prior to this release that identified course sections with more than one **EMIS Override** record. You can use this data after installing the release to verify that the remaining **EMIS Override** records have the correct values.

MAJOREMIS

(D12220) Previously, the Student Majority of Attendance IRN Verification (MAJOREMIS) process on the **9th or After FY 15** tab did not include students withdrawn after March 19 but prior to April 13. Now, all students are updated with the correct IRN value.

Fall Initialization

- (D9170) Previously, when a withdrawn student was re-enrolled in the next school year, when you ran the Verify process, the Fall Initialization Verification Report displayed the CurrentReportToEMIS field as blank. Now, in these circumstances, the CurrentReportToEMIS field displays as FALSE or TRUE depending on whether you select the option Students excluded from Fall Initialization when running the Verify process.
- (D9091) Previously, when you ran the **Verify** process with the **Students promoted but withdrawn before 6/30** option selected, withdrawn students who were promoted to the next school year did not display in the Fall Initialization Verification Report. Now, in these circumstances, the report contains the correct students.
- (D11209) Previously, when the Fall Initialization process was already run for a school year, you were able to re-run Fall Initialization without confirmation, which sometimes resulted in data loss. Now, if Fall Initialization has already been run for the school year in context, a confirmation message displays prompting you to confirm you want to run Fall Initialization.

Note: Only confirm if you are absolutely certain that you want to run Fall Initialization for the school year in context.

PSAT/NMSQT

• (D11262) Previously, the rows within the **Category / Score** column of the test results grid were not alternately shaded for easy viewing. Now, the rows display correctly.

Assessment Transfer - Collection (A)

(D12187) Previously, when students completed a COS assessment prior to or after a district enrollment date of 7/1 of the school year, they were not included in the Period A Transfer - Preschool COS (GM) process. Now, in these circumstances, these students are included in the process.
