

V17.2.2 RELEASE NOTES

StudentInformation v17.2.2 provides several new features and resolves some issues to improve your experience. This overview explains the recent changes.

Enhancements

StudentInformation

Student Absence Intervention

- A new screen has been added on the student **Attendance** menu. On this screen, you can view a summary of the student's excessive absences, habitual trancies, and any thresholds the student has met. You can also view the district's responsibilities; create and update absence intervention information and parental contact records for the student; and print absence intervention letters. Users must have the proper security settings in order to view and/or modify this screen. (*ProgressBook StudentInformation Attendance and Calendar Guide, ProgressBook StudentInformation HB410 District Task List*)

Report Template Administration

- You can now upload **Absence Intervention Letter** report templates by district.

Attendance Calculations

- (E12830) You can now enter absences with a **Qualifier** of **Late/Tardy** with only a **Time Out** value to record when a student leaves a building near the end of the day. This lets districts have such **Late/Tardy** absences display on the student's report card. (*ProgressBook StudentInformation HB410 District Task List*)
- Attendance calculations now support schools that use period attendance.

Note: *If your school is using period attendance and has any daily absences entered for any students (e.g., a full day absence instead of an all-periods absence), you must re-enter these absences as period absences.*

StateReporting

Student Reporting - Collection (S)

- A new **Transfer - Student Truancy and Excessive Absence (FT)** option is now available to accommodate HB410 reporting requirements. (*ProgressBook StudentInformation EMIS Guide, ProgressBook StudentInformation HB410 District Task List*)

Edit Student Profile

- The **FS-Attendance** tab now has a link to the new **Student Absence Intervention** screen. You must have appropriate security privileges to view this screen. (*ProgressBook StudentInformation Student and Registration Guide*)

ATTUPEMIS

- ATTUPEMIS now uses the attendance and absence values from the HB410 attendance calculations.

Course Sections

- (E5748) When you add or edit a course section, on the **EMIS Override** tab, you can now enter an **EMIS Location IRN**. (*ProgressBook StudentInformation Scheduling Guide*)
- (E5748) The following screens now display the **EMIS Location IRN** override values if applicable:
 - Course Curriculum (CRSE) Report
 - Shared Student Data (JVS/Home)
 - Student Eligibility Details
 - Student Course History

Staff/Course Reporting - Collection (L)

- (E5748) From FY18 and forward, the **Verify/Update - Course and Class List (CLISEMIS/CTRMEMIS)**, **Transfer - Course Master (CN)**, and **Transfer - Staff Course (CU)** processes now include the **EMIS Location IRN** if entered, from the course sections' **EMIS Override** tab.

Import/Export

- (E5748) The **Battelle for Kids Export** and **eTranscript Transfer** now include the **EMIS Location IRN** override if applicable.

Student Memberships

- (E12742) From FY18 and forward, the program **221005 - Participation in Coordinated Early Intervening Services** has been added to membership group **22 - Disadvantaged Pupil Programs**.

Assessment Imports

- (E12649) New DORP assessment subject areas are now supported.

Note: Records for non-EMIS required assessments (*Language, Science, Algebra*) do not import and are listed on the **Error** tab.

Resolved Issues

Student Information

Daily Absence List / School Absences

- (D12806) Previously, when you added or edited an absence with a **Time In** and/or **Time Out** value of **12:00 AM**, the time did not display in the absence grid. Now, in these circumstances, **12:00 AM** displays correctly.

***Note:** 12:00 AM is still an invalid time value for attendance calculations and absences with a **Time In** and/or **Time Out** value of 12:00 AM are still skipped during the calculations.*

- (D12806) Previously, due to VendorLink entering time values of 12:00 AM when a vendor did not provide a value, absences were incorrectly saving with values of 12:00 AM. Now, before the attendance calculations run, a script updates all values of 12:00 AM to null.

***Note:** For 17.3.0 and forward, VendorLink will enter null values when a vendor does not provide a value and the script will no longer run.*

Attendance Calculator

- (D12876,12880) Previously, when you deleted absences for a student or updated absences to non-absences, if the student had no other existing absences, the attendance calculator did not register the change and the student appeared to still have absences. Now, in these circumstances, the attendance calculator updates the student's record correctly.

Archived Report Card Maintenance

- (D12909) Previously, while on the **Archived Report Card Maintenance** screen, when you had in context a student who was enrolled in a future school year, all archived report cards incorrectly displayed. Now, in these circumstances, you cannot see any report cards for such a student.

Course Section Assignments

- (D12936) Previously, when you used **Drop All Assignments** to drop course section assignments, the course sections were incorrectly deleted instead of recorded as dropped. A script has been included in the release to update all incorrect values.

StateReporting

Student Registration

- (D11888) Previously, when you tried to register a previously enrolled student and selected a strict match, if the student had an inactive **EMIS Situation** code, an error occurred. Now, in these circumstances, the student's **EMIS Situation** code populates with the code from the **Registration Defaults** screen and you can complete the registration process. If you have permission to access the **EMIS** tab, you can update the default **EMIS Situation** code to an applicable value if necessary.

KRA

- (D12795) Previously, when you tried to add a KRA assessment manually but did not enter any error band scores, an error occurred. Now, in these circumstances, you can save the KRA assessment without error.
