Enhancements

StudentInformation

Ad Hoc Reports

The user interface has been updated to include new elements.

Graduation Points

- (E13393) From FY18 and forward, students are now required to take the following 7 federal and state required assessments to graduate:
 - Algebra I (ALG1) or Integrated Math I (MTH1)
 - Geometry (GEOM) or Integrated Math II (MTH2)
 - English I (ELA1)
 - English II (ELA2)
 - Biology (BIOL)
 - American History (HIST)
 - American Government (GOVM)

(E13484) From FY18 and forward, there are two new valid Industry Credential
 Assessment codes available for students who meet the Industry Credential pathway for
 graduation. The following codes apply to both the Agricultural & Environmental and

Notifications

- Administrators can now configure notification rule settings at the district and building level and can temporarily turn off or on certain notifications. (*ProgressBook StudentInformation Notifications Guide*)
- Below My Account, users can now access the Notifications menu to view their notifications on the Notification List screen or manage their subscriptions to notifications on the Subscription List screen. (ProgressBook StudentInformation Notifications Guide)
- Users can now receive notifications for the following notification rules depending on their district, building, and individual settings: Custody Alert, Discipline Incident, Discipline Referral, Medical Alert, and Quiz Submitted. (*ProgressBook StudentInformation Notifications Guide*)

Resource Permissions

 When you add or edit a security role and click Edit Resource Permissions, you can now navigate to the Notifications tab to configure the role's access to each available notification rule. (ProgressBook StudentInformation Notifications Guide)

Shared Student Data

- The **Shared Student Data (JVS/Home)** screen has been renamed **Shared Student Data**. (*ProgressBook StudentInformation EZ Query Guide*)
- When you select Daily Absences from the Choose data to review drop-down list, the
 new Attendance Hours Summary grid displays, containing the student's Total Excused
 Hours and Total Unexcused Hours for each school they attend as well as the Total
 Hours of excused and unexcused absences for all schools combined. Values on the
 Attendance Hours Summary grid update when the attendance calculator is run.

User Interface

• In the StudentInformation application header, you can now click to view your last 15 notifications; you also have the option to click **Notifications** to access your **Notifications List** or click **Subscriptions** to access your **Subscription List**. When you receive a new

View Groups

• When you add or edit user groups, on the **Group** tab, you can now select the new **Attendance Coordinator** job function.

View Staff Members

Assessment Reporting Collection (A)

- The **Verify Preschool COS (GM)** process now includes the following three revised error messages:
 - PS student is missing a Spring COS assessment record.
 - PS student needs Fall and Spring COS assessment records.
 - PS student is missing a Fall COS assessment record.
- (E12887) The **Verify ELA(GB)** process now includes new error messages and date validations according to the following general rules:
 - The Fall window is now 08/01 11/30 and the Spring window is now 02/01 05/31.
 - Excludes students who are withdrawn from the district before the start of school.
 - Excludes non-attending graduate students.
 - Only includes students who have the Report To EMIS check box selected on their Edit Student Profile screen General tab.
- (E12886) The **Verify KRA(GO)** process now includes new logic for existing error messages and two new error messages.

(E13446) On the CTE Technical Score tab, when you click Add CTE Technical
 Assessment, the CTE Student Assessment Code drop-down list now includes 16MD Early Childhood Education.

Edit Student Profile

 The FN-Graduate tab Proficient Foreign Languages multi-select list now includes the following five additional languages: Central Khmer, Croatian, Fulah, Persian, Pushto, and Trigriyan.

 (E13483) From FY18 and forward, when you select the GW-205 - Assessment Area Code option from the drop-down list, the following new industry credential assessment codes display:

Graduate Reporting - Period (G)

(E13188,E13110) From FY18 and forward, the new Transfer - Student Program (GQ) process lets you submit all GQ records for graduating students. This transfer also includes the 510001 - Ohio Means Jobs membership. (*ProgressBook StudentInformation EMIS Guide*)

Resolved Issues

StudentInformation

Ad Hoc Reports

(D13520) Previously, an update to Ad Hoc Reports caused the **Database Row Limit** value to reset to **20,000**, which sometimes caused issues when reports were run for entire districts or multiple schools. Now, the value has been updated to **300,000**.

Core Overflow

 (D11828) Previously, with the current school year in context, when you tried to add a new Core Overflow and clicked Save, an error occurred. Now, in these circumstances, you receive a warning message stating that you cannot add a new overflow.

Graduation Points

- (D13374) Previously, on the State Assessment Pathway screen, when a student had IEP exemptions for dual subject End of Course assessment areas, such as ALG1 and MTH1, but only took the End of Course exam for one subject, such as ALG1, both IEP exemptions incorrectly displayed. Now, only the IEP exemption(s) with the corresponding End of Course exam(s) taken displays.
- (D13433) Previously, when a student's Fiscal Year Began 9th value on their Edit
 Student Profile screen FN-Attributes tab was 2015 and they had a manually-added
 physical science course in the 2015 (or prior) summer term, you received an error on the
 Grad Points Summary screen if you clicked Check for Updated Information. Now, in
 these circumstances, the screen no longer returns an error.

Homeroom Bulk Assignment

• (D13432) Previously, on the **Multiple Homerooms** tab, when the **Class Period** radio button was selected for the **Select Students By** field and you clicked **Assign Students**, the screen timed out. Now, in these circumstances, the screen no longer times out.

Shared Student Data

(D3817) Previously, when you selected EMIS - FS from the Choose data to review drop-down list, depending on the corresponding values on the student's Edit Student Profile screen FS-Standing tab, the Sent To 1 IRN and Sent To 2 IRN values sometimes displayed incorrectly. Now, in these circumstances, the Sent To 1 IRN and Sent To 2 IRN values display correctly.

StateReporting

Assessment Imports

• (D13438) Previously, the **Redesigned SAT (New Format as of 10/2015)** assessment import timed out for large districts. Now, the import runs successfully.

Calendar Reporting - Collection (C)

(D9763) Previously, the Transfer - Building and Grade Calendar (DN/DL) process
incorrectly included inactive sub-calendars with the Report to EMIS check box selected.
Now, only active sub calendars with the Report to EMIS check box selected are included.

Student Transfer - Collection (S)

(D11129) Previously, when you ran the Verify/Update - Majority of Attendance IRN (MAJOREMIS) process and selected the Untested and Alternate tab, the Ad-Hoc Membership for Alternative Assessment Students drop-down list displayed the ad-hoc membership names incorrectly. Now, in these circumstances, the ad-hoc membership names display correctly.
