

V18.3.0 RELEASE NOTES

StudentInformation v18.3.0 provides several new features and resolves some issues to improve your experience. This overview explains the recent changes.

Enhancements

StudentInformation

Attendance Fast Entry/Update

- The **Attendance Fast Entry/Update** screen now displays absences for days that are attending days on the sub-calendar but are non-attending days on the master calendar.

Courses

- When you add or edit a course, on the **Miscellaneous** tab, the **Location Types Available** and **Location Types Selected** dual listboxes no longer display. (*ProgressBook StudentInformation Scheduling Guide*)

Miscellaneous Data Groups Maintenance

- When you view data definitions on the **Miscellaneous Data Definitions Maintenance** screen View Definitions grid, the **Searchable** column no longer displays. When you add or edit a miscellaneous data definition, the **Is Searchable** check box no longer displays. (*ProgressBook StudentInformation Student and Registration Guide*)

Pre-Identification Export

- When you run the **Pre-Ident for Pearson Educational Measurement Export**, the file now includes the new layout according to ODE requirements and only includes students who are still required to pass all parts of the OGT assessment.
- On the **Pre-Ident for Pearson Educational Measurement Export** screen, instead of selecting the **Include only required students** check box, you can now select an ad-hoc membership or enter comma-separated student numbers to include only specific students in the export.

- When you run the **Pre-Ident for OELPA Export**, the file now includes column headers for OGT assessments to accommodate new ODE requirements.
- On the **Pre-Ident for OELPA Export** screen, you now have the option to select an ad-hoc membership for ELPA21 screener students or enter comma-separated student numbers to include only specific students in the export. (*ProgressBook StudentInformation Import/Export Guide*)
- When you run the **Pre-Ident for Next Generation Assessment Export**, the file now includes column headers for OGT assessments to accommodate new ODE requirements.
- When you run the **Pre-Ident for End of Course Exam Export**, the file now includes column headers for OGT assessments to accommodate new ODE requirements.

Registration Wizard

- The **EMIS** tab now includes the **Legal Name Suffix** and **Birth Gender** fields. (*ProgressBook StudentInformation Student and Registration Guide*)

Student Email Import

- (E9437) When you run the **Student Email Import**, a grid now displays with information regarding any invalid student number or email address errors. (*ProgressBook StudentInformation Import/Export Guide*)

Student's School Absences

- On the **Daily Attendance** or **Period Attendance** tab, when you click **Show Full Year Attendance Statistics**, the grids that display now include records for days that are attending days on the student's sub-calendar even if they are non-attending days on the master calendar.

StateReporting

CTE Student Assessment (OCTCA)

- The following OCTCA assessment codes are now spelled correctly:
 - CBY5 – Introduction to Marketing
 - CTK0 – Introduction to Entrepreneurship
 - HUJ0 – Legal Office Management and Support
 - HUK0 – Medical Office Management and Support

Graduate Reporting - Collection (G)

- (E63452) The **Transfer - OGT (GX)** process now includes test dates of YYYYMMDD for assessments taken from 07/01/2018 and forward.

Ohio Graduation Test

- (E63452) All existing and new OGT records now display a **Test Date** of MM/DD/YYYY on the records grid. (*ProgressBook StudentInformation Assessment Guide*)

Resolved Issues

Student Information

Ad Hoc Reports

- (D13588) Previously, the default Date setting incorrectly used DateTime instead of Date, which affected some reports. Now, it correctly uses Date.

Address Standardization

- (D13560) Previously, when you ran the address standardization service, it failed when there were too many addresses to standardize. Now, the service correctly processes 100 addresses at a time for multiple passes if needed.

Attendance Fast Delete

- (D1350) Previously, the **Attendance Fast Delete** screen did not display absences for days that were attending days on the sub-calendar but were non-attending days on the master calendar. Now, in these circumstances, the absences display.

Download Student Address

- (D13571) Previously, when you tried to download student addresses without selecting any student status codes, an error occurred. Now, the process runs successfully.

SAS Pre-Identification Export

- (D12738) Previously, the **SAS Pre-Identification Export** screen incorrectly displayed inactive school districts for the school year in context. Now, only active school districts for the school year in context display.

Shared Student Data

- (D13569) Previously, when you selected **Address and Primary Contact** from the **Choose Data to Review** drop-down list and then selected **Primary Contact** from the **Address or Primary Contact** drop-down list, an error occurred. Now, in these circumstances, the screen loads successfully.

SIS Student Search

- (D13572) Previously, on the **Field Selection** tab, the **Program** field incorrectly displayed within the **EMIS** subtab **General** accordion list, which limited users who did not have access to the **EMIS** subtab. Now, the **Program** field displays on the **Enrollment** subtab instead.

Study Hall Wizard

- (D2710) Previously, on the **Study Hall Parameters** tab, if you did not select and save any grade levels, an error occurred when you ran the Batch Scheduler. Now, if you did not select any grade levels, the report saves and uses all grade levels when the Batch Scheduler is run. (*ProgressBook Student Information Scheduling Guide*)

StateReporting

Edit Student Profile

- (D12400) Previously, on the **FD-Attributes** tab, when you added an FS record for a student after a withdrawal has been completed but the FD record is within the timeframe that the student is enrolled, the withdrawal date incorrectly displayed on both FD records. Now, the withdrawal date only displays on the most recently dated FD record correctly.
