

V18.4.0 RELEASE NOTES

StudentInformation v18.4.0 provides several new features and resolves some issues to improve your experience. This overview explains the recent changes.

Enhancements

StudentInformation

Assessment Maintenance

- (E13648) The **Assessment Maintenance** screen has been added so that ITCs can delete assessment results that were imported to the **Assessment Imports** screen. (*StudentInformation Assessment Guide*)
- The screen contains a message indicating that you may need to delete corresponding assessment files in DataMap.

Attendance Calculator

- The Attendance Calculator now summarizes the DailyAbsencebySchool data for export by school and year and includes the number of times students were tardy.

Home School Export

- The export now includes the following fields for HB410:
 - **Hours Attended**
 - **Hours Absent Excused**
 - **Hours Absence Unexcused**
 - **Hours Out of School Suspension**

Home School Import

- The import now includes the following fields for HB410:
 - **Hours Attended**
 - **Hours Absent Excused**
 - **Hours Absence Unexcused**

- **Hours Out of School Suspension**

- The warning message regarding Internet Explorer version 11.0.9600.17207 has been removed.

Student's External Absences

- In compliance with HB410, the following fields have been added to the screen:

- **Hours Attended**
- **Hours Absent Excused**
- **Hours Absence Unexcused**
- **Hours Out of School Suspension**

StateReporting

CTE Industry Credential

- When you select a **Testing Date** prior to FY14, a message now displays indicating that you must choose one in FY14 or later.

CTE Student Assessment (OCTCA)

- On the **CTE Technical Score** tab, in the **CTE Student Assessment Code** drop-down list, the **14MD - Teaching Professions** option is now available.

DASLSyncer

- You can now retrieve new biliteracy codes using the syncer.

DataMap EMIS Import

- The **DataMap EMIS Import** screen has been added so that you can import RIMP Program Codes to add students to related Memberships. You can also import RIMP On-Track Statuses from DataMap. *(StudentInformation EMIS Guide)*

Edit Student Profile

- On the **FN-Attributes** tab, when you select **12 - Information Technology** from the **CTE Program Area** drop-down list, the **N4 - Cyber Security** program concentration now displays as an option in the **CTE Program of Concentration** drop-down list.

Graduation Only Test Record

- This screen has been removed since the same functionality is available using the **Student is a Non-Attending Graduate** option in the Registration Wizard. *(StudentInformation EMIS Guide)*

International Baccalaureate (IB)

- The new **IB99 - Other IB assessment not otherwise listed** code has been added to the **Assessment Area Code** drop-down list to be used in circumstances where no EMIS assessment code exists for the IB assessment.

Student Information Options

- On the **Attendance** tab, the **Attendance Officer** drop-down list has been removed. (*Student Information School Year Setup and Configuration Guide*)

User Interface

- (E13405) All instances of the **Attending District IRN Last October** field have been updated to **Previous Year District IRN**. (*Student Information Ad Hoc Updates Guide*, *Student Information EMIS Guide*)
- All instances of “OCBA” (Ohio Computer-Based Assessment) have been updated to “OST” (Ohio’s State Tests). (*Student Information Assessment Guide*)

Verify Student Demographics

- (E13013) The system now verifies whether a student is assigned a **Primary Building** on the **Edit Student Profile** screen **Additional** tab.

Resolved Issues

Student Information

Analytics Hub

- (D13663) Previously, when you had the **AH-Full Admin Viewer** user role, the parameter screen did not display once you selected an ad hoc report. Now, in these circumstances, the parameter screen displays and you can run the report.

EZ Query Discipline

- (D12991) Previously, when the **Description** of a discipline incident contained more than 2000 characters, you received an error when navigating to this screen. Now, in these circumstances, the screen loads successfully with the full description.

Grad Points Summary

- (D13670) Previously, in some circumstances, when a student met End of Course Assessment requirements, completion was not reflected on this screen. Now, when students finish these requirements, their completion is reflected.

Home School Import

- (D13218) Previously, on the **Students** tab, when you re-enrolled a student at a school, the **Reporting Calendar** on the **Edit Student Profile** screen **FD-Attributes** tab defaulted to the first calendar in the drop-down list rather than the **Default Calendar** chosen on the **Student Information Options** screen. Now, the **Default Calendar** is assigned to a student that is in these circumstances.

Miscellaneous Data Groups

- (D13704) Previously, when you tried to add or edit a **Data Definition**, an error occurred. Now, you can add or edit a **Data Definition** successfully.
