

## **v18.6.0 RELEASE NOTES**

StudentInformation v18.6.0 provides several new features and resolves some issues to improve your experience. This overview explains the recent changes.

### **Enhancements**

#### **StudentInformation**

##### **Ad Hoc Reports**

- The loading time for the drop-down lists in the following reports has been improved: **FY19 - Preschool ELA Pre-ID Enrollment File** and **FY19 - Preschool ELA Pre-ID Teacher File**.
- Using the ExagoScheduler Config Utility, you now have the ability to enable FTP logging. (*ProgressBook Additional Tasks v18.6.0 Post Installation*)
- The **ACT Pre-ID** and **SAT Pre-ID File** reports have been updated according to ODE standards.
- The new **JVS Pre-ID** report lets you create the Pre-ID file to upload for the ACT State Test day for 11th grade JVS students.

##### **Attendance Calculator**

- (E13024) When a student's **Edit Student Profile** screen **FN-Attributes** tab has the **Report to EMIS** checkbox de-selected but the calendar to which they are assigned has the **Include in attendance calculation** checkboxcheckbox selected, attendance is now calculated for the student.
- When a student has period absences that exceed their **Hours Per Day** value by more than one period, the student is no longer skipped in attendance calculations. (*ProgressBook StudentInformation HB410 District Task List*)

##### **Grad Points Summary**

- (E13532) The **2018 Optional Pathways** tab is now available for students who have a **Fiscal Year Began 9th** value of **2015** on the **Edit Student Profile** screen **FN-Attributes** tab.

## Resolved Issues

### Student Information

#### Ad Hoc Reports

- (D13934) Previously, you were unable to run express reports from any folders other than **My Reports**. Now, you can always run express reports from any folder.
- Previously, scheduled reports sometimes failed to complete successfully. Now, all scheduled reports run successfully.
- (13737) Previously, the **MonthlySummaryMonthName**, **MonthlySummaryAbsenceHours**, and **MonthlySummaryAbsenceDays** bookmarks used only the first month of the school year instead of all applicable months, which resulted in absence intervention letters with incorrect information. Now, all relevant months of the school year are included in the absence intervention letters.
- Previously, on the **5 Credit Check Rule** report, if the same course section ID showed up in succession in the dataset, it was viewed as a duplicate, and the second entry was excluded from the report. Now, all course sections display correctly.

#### Admission/Withdrawals (AWEX)

- (D11017) Previously, when a student's calendar was updated to a non-attending calendar, the AWEX report interpreted the change as a new building admission date. Now, the AWEX report recognizes that a student's calendar change is not a building admission event.

#### Attendance Calculator

- (D13602) Previously, when a student was assigned a calendar but then was reassigned a new calendar that has not started yet, the student's attendance and absences were not cleared when you ran the attendance calculator. Now, in these circumstances, the student's attendance and absences are cleared.

#### DataMap EMIS Import

- (D13828) Previously, when you ran the import, an error sometimes occurred. Now, you can run the import only at the building level, so the import always runs successfully. (*ProgressBook Student Information EMIS Guide*)

#### Grad Points Summary

- (D13371) Previously, when you added a special education IEP graduation exemption for MTH1, MTH2, GEOM, or ALG1, the corresponding completion indicator in the **Required State Assessments** section changed to incomplete if the End Of Course exam was worth fewer than 3 points. Now, in these circumstances, the completion indicator remains.

- (D13246) Previously, when a student had an IEP marked as graduation-exempt for a particular subject on the **Special Education** screen **Grad Requirement** tab but later had a new IEP with no graduation exemption for the same subject, the previous IEP took precedence over the new IEP, which inaccurately indicated on the corresponding subject area of the **State Assessment Pathway** screen that the student was exempt from graduation for that subject. Now, the most recent IEP takes precedence and correctly indicates that the student is not exempt from graduation for that subject.

### **View Pending Students**

- (D10884) Previously, when student had the **Hispanic/Latino** field set to \* - **Not Collected** and had no **Racial Group(s)** selected and you transferred them to a new district with registration defaults specified for these fields, the **Hispanic/Latino** field and the **Racial Group(s)** selections remained blank. Now, in these circumstances, the student's fields in the new district populate with the registration defaults.
- (D13644) Previously, the bulk enrollment of students transferred in failed when an incoming student matched an existing student by SSID, and it did not continue enrolling other students. Now, in these circumstances, the enrollment continues to run, and a grid displays at the end of the process indicating which students failed to be enrolled in the school.

## **StateReporting**

### **Battelle for Kids Export**

- (D13816) After the release of StudentInformation v18.3.0, the export returned an error. Now, the export runs successfully.
- (D13817) Previously, the Student Information Export, School Information Export, and Employee Information Export omitted the leading zeros in the District IRN for each export format, which caused importing the exported file into third parties, such as Roster Verification, to fail. Now, the leading zeros are included in the District IRN field in the exports.

### **Graduate Reporting - Collection (G)**

- (D13797) Previously, the **Transfer - Student Special Ed. Graduation Requirement** process included the incorrect assessment type value of GX for both End of Course and OGT records. Now, the process includes the assessment type value of GX for OGT records and GE for End of Course records.

### **Assessment Imports**

- (D13891) Previously, the KRA Import incorrectly imported scores into the wrong score fields. Now, the scores import into the correct score fields.
